STRATEGY STATEMENT

The priorities for Knole Academy for catch up are to minimize the impact for the new Year 7 pupils who on initial teaching seem to have suffered most in terms of learning loss over the lock down.

Secondly, to support the Year 10 and 11 students to ensure they are prepared for external examinations. The Academy is confident we will have taught all curriculum material but the exam skills and revision will have been truncated due to lost learning time.

Thirdly, to be able to more effectively support remote learning, we have lent over 200 laptops to students over lockdown, some of which have been broken and this has left provision in school below optimum levels.

Finally to support new Covid working practices, we have changed our mobile phone policy to allow use in school for internet searches and to email work between students and teachers, this has required significant infrastructure changes.

We are confident that the strategies that we undertook during lockdown have not led to a widening of gaps for disadvantaged and all measures will mitigate against overall learning loss.

The academy has always conducted baseline tests in English and maths for all incoming Year 7 students, on average this cohort is 18 months behind previous cohorts. We are targeting students who have demonstrated the lowest levels of academic performance for additional tuition, we are also doing this for the least academically able Year 8 students where we believe the lock down has caused the greatest regression in knowledge. Targeted tuition is also being implemented for students that are currently not fully engaging in their education.
